Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

Precautions for safe handling

Protective measures

• Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems or asthma, allergies or chronic or recurrent respiratory disease should not be employed in any process in which this product is used.
